## WAIVER OF LIABILITY AND HOLD HARMLESS AGREEMENT

**In consideration for** receiving permission to participate in the Alaskan Malamute Club of Wisconsin, Inc. ["AMCW"] weight pull ["Pull"] at the Waukesha JanBoree at Minooka Park in Waukesha, WI as described on the Weight Pull Entry form on the reverse side of this agreement. I hereby release, waive, discharge and covenant not to sue the AMCW or Waukesha County, their officers, members, agents and employees [herein referred to jointly as the "Club"] from any and all liability, claims, demands, actions and causes of action whatsoever arising out of or relating to any loss, damage or injury, including death, that may be sustained by me, or to any property belonging to me, whether caused by the negligence of the Club, or otherwise, while participating in the Pull, or while on the premises of the host site where the Pull is being conducted ["Premises"], while in transit to or from the Premises, or in any place or places connected with the Pull. ["Release"]

**I am fully aware of** the risks and hazards connected with being on the Premises and participating in the Pull, and I am fully aware that there may be risks and hazards unknown to me connected with being on the Premises and participating in the Pull, and I hereby elect to voluntarily participate in the Pull, to enter upon the above named Premises and engage in activities knowing that conditions may be hazardous, or may become hazardous or dangerous to me and my property. I voluntarily assume full responsibility for any risks of loss, property damage or personal injury, including death, that may be sustained by me, or any loss or damage to property owned by me, as a result of my being a participant in the Pull, whether caused by the negligence of the Club or others.

**I further hereby agree** to indemnify and save and hold harmless the Club, from any loss, liability, damage or costs they may incur due to my participation in the Pull; whether caused by the negligence of any or all of the Club, or others.

**It is my express intent** that this Release shall bind the members of my family and spouse, if I am alive; and my heirs, assigns and personal representative, if I am deceased; and shall be deemed as a release, waiver, discharge and covenant not to sue the above named Club.

**In signing this Release,** I acknowledge and represent that:

- A. I have read the foregoing Release, understand it, and sign it voluntarily as my own free act and deed;
- B. No oral representation, statements or inducements, apart from the foregoing written Weight Pull Entry agreement, have been made;
- C. I am at least eighteen [18] years of age and fully competent; and
- D. I execute this Release for full, adequate and complete consideration fully intending to be bound by same.
